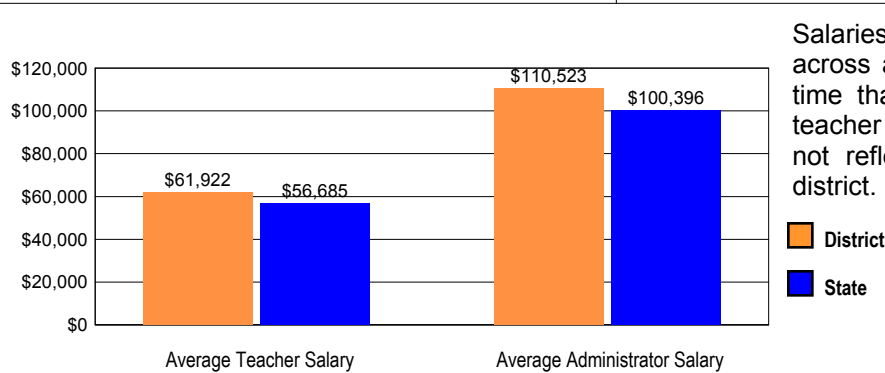

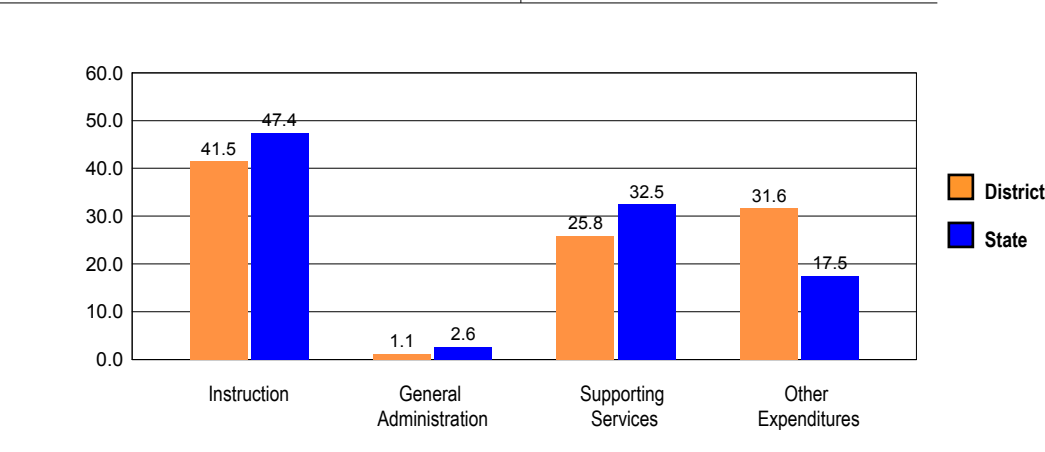
SCHOOL DISTRICT FINANCES

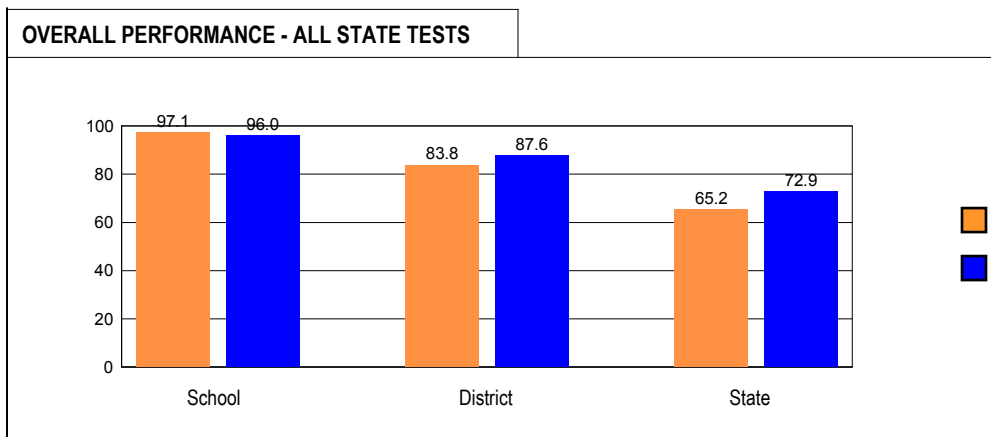

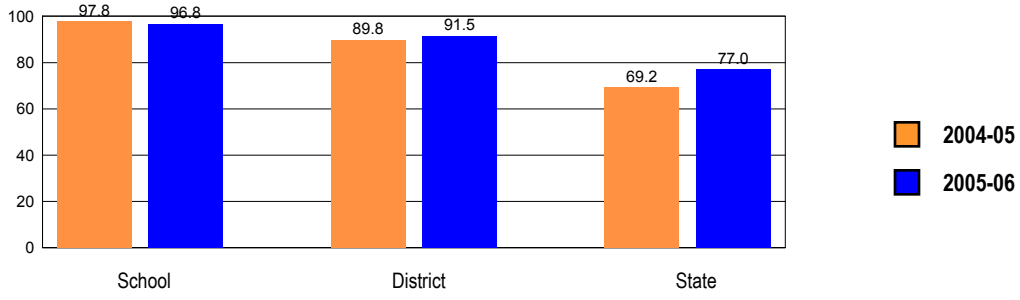
OVERALL STUDENT PERFORMANCE

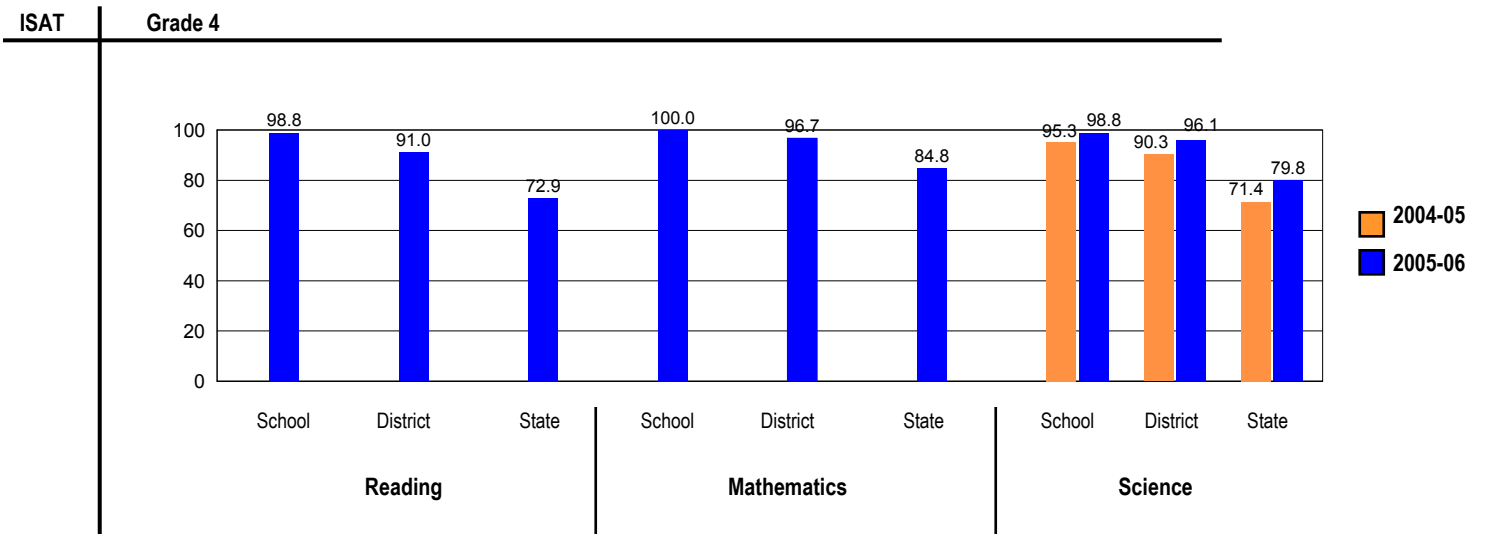
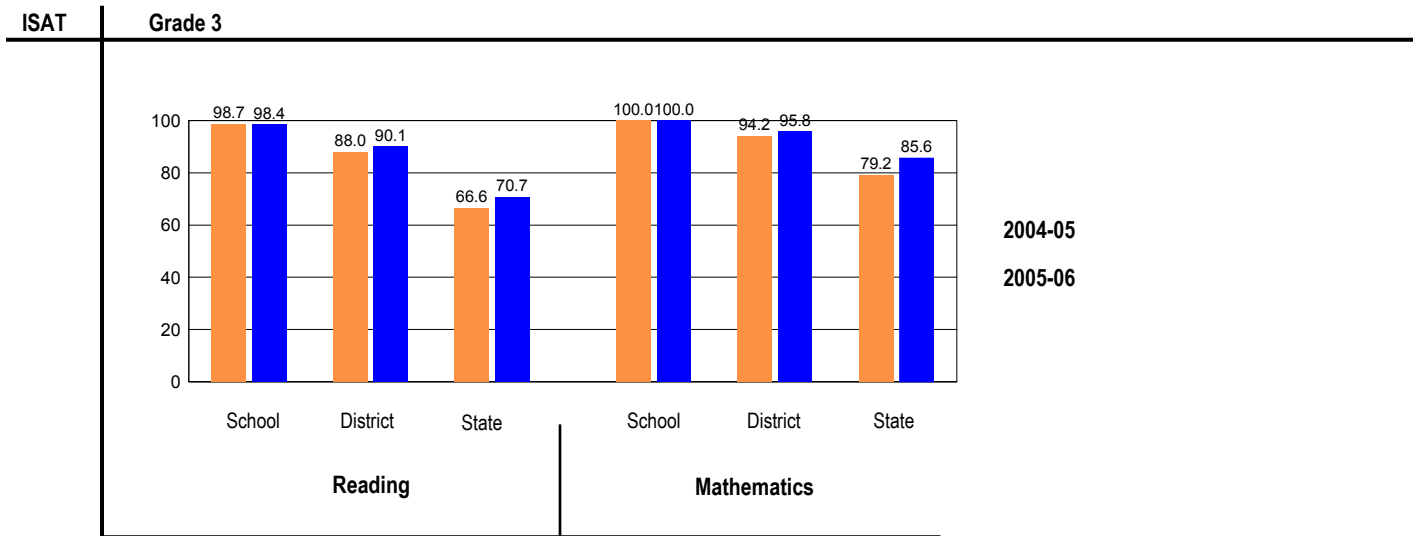


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE



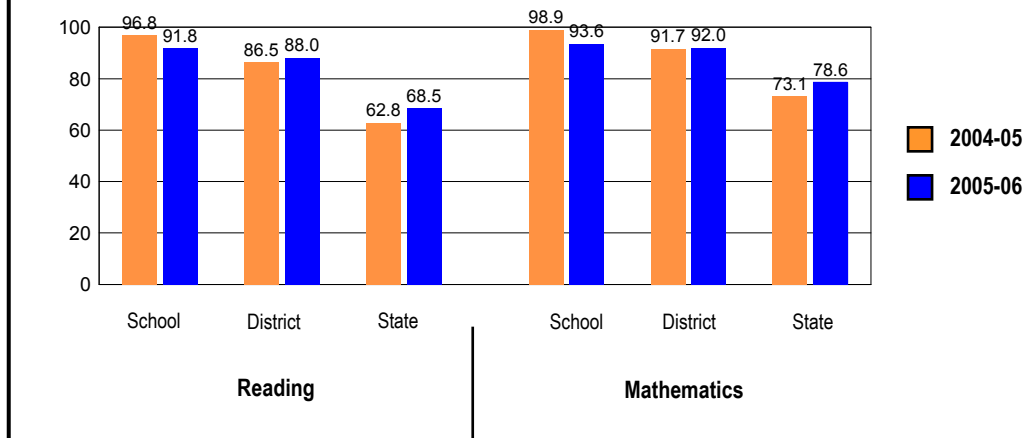
ISAT PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Schools with grade 2 as the highest grade in the school use a state-adopted test in reading and mathematics to meet this requirement.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

The four conditions for making Adequate Yearly Progress (AYP) are:

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 47.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 47.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 47.5% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 89% attendance rate for non-high schools and at least 69% graduation rate for high schools.

*** Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. SCHOOL IMPROVEMENT PLAN
2006-07**

Based on the 2006 ISAT data, Whittier School continues to make excellent progress in reading and math. The information provided here is a brief summary of the goals included in the Whittier School Improvement Plan (SIP) for 2006-07.

Target Areas for Student Improvement

- In the area of reading, 95% of third and fifth grade students, at a minimum, will meet or exceed state standards in reading as measured by the 2007 ISAT Reading tests. Special focus will be given to vocabulary development and use of inferential strategies.
- In the area of math, 95% of third and fifth grade students, at a minimum, will meet or exceed state standards in mathematics as measured by the 2007 ISAT Mathematics test. Special focus will be given to the use of math vocabulary, problem solving skills, and the ability to explain mathematical thinking in a written format.

Rationale for Target Selection

- **READING:** In third grade, 98% of students met or exceeded state standards. In fourth grade, 100% of the students met or exceeded state standards. In fifth grade, 92% of students met or exceeded state standards. Vocabulary continues to be a sub-score that shows a consistent drop from 3rd to 5th grade, making it a logical target for improvement. Continued emphasis on all inferencing skills will lead to better comprehension, as well as improvement in constructing a written response to reading.
- **MATH:** 98% of all third grade students, 98% of fourth grade students, and 94% of all fifth grade students met or exceeded state standards. The understanding and consistent use of math vocabulary will improve overall math achievement, as will continued emphasis on problem solving and written response in mathematics.

Strategies for Improvement

- Using a variety of assessments, teachers will monitor student progress in reading and provide needed interventions for at-risk students.
- Grade level teams of teachers will plan ways to expand children's understanding and usage of rich, interesting vocabulary words to improve reading comprehension.
- Teachers will design student resources for understanding and applying key math vocabulary terms.
- Teachers will continue to use ISAT rubrics and present instructional strategies to improve written responses to reading, as well as open-ended math responses.

Professional Development Opportunities

- Teachers will participate in professional development opportunities provided by District 200 such as inservice days, workshops, and grade level training sessions related to SIP.
- Building funds allocated for staff development will be used to send teachers to out-of-District workshops related to school improvement goals. Information will be shared with fellow staff members.
- Primary and Intermediate Council meetings will be focused on school improvement goals and methods to support the accomplishment of those goals.
